

Certification and Recertification of practising adult colonoscopists

National Safety and Quality Health Service Standards

Certification and recertification in adult colonoscopy are mandatory for all practitioners working in health service organisations being assessed to the National Safety and Quality Health Service (NSQHS) Standards.

Medical and surgical endoscopists

Certification

- Certification is a formal recognition of training that ensures clinicians have met the required procedural standards colonoscopy.
- Certification of gastroenterologists, surgeons and general practitioner endoscopists is through the Conjoint Committee for the Recognition of Training in Gastrointestinal Endoscopy (<u>CCRTGE</u>).
- CCRTGE is a national body comprising Gastroenterological Society of Australia (GESA), the Royal Australasian College of Physicians (RACP) and the Royal Australasian College of Surgeons (RACS). It sets the minimum standards for training in adult colonoscopy.
- Colonoscopy training is usually assessed and certified in the context of College Specialist Advanced Training Programs but the CCRTGE also assesses other training options.
- The Experienced Practitioner Pathway (EPP) is available for experienced clinicians
 who were not assessed for certification in the context of their College Specialist
 Advanced Training Program (usually because their training antedated the CCRTGE).
 - EPP pathway logbooks require a minimum of 200 colonoscopy procedures to be logged. These can be retrospective cases, however 10% of logged procedures must be under the direct supervision of a CCRTGE recognised adult colonoscopist (who is a more experienced practitioner or in a more senior position).
- The CCRTGE also offers pathways for the assessment of overseas specialists with prior training and endoscopic experience seeking to practice in Australia.









Steps in the certification process for practicing adult colonoscopists applying through EPP are:

- Register and pay enrolment fee through <u>CCRTGE</u> website
- Provide evidence of experience
- Provide evidence of admission as a fellow to an Australian medical college accredited by the Australian Medical Council at least five years prior to application
- Organise supervision by a CCRTGE recognised adult colonoscopist. Supervisors must generally be an experienced practitioner or in a more senior position.
- Go online and establish your CCRTGE logbook for adult colonoscopy
- Log relevant procedures
- Pay logbook submission fees
- Submit online application for certification under the EPP to CCRTGE

Recertification

- Recertification supports colonoscopists to maintain their expertise in colonoscopy, to continue to develop their skills and to increase the safety and quality of care being delivered to patients.
- Recertification of medical and surgical endoscopists is through the Recertification in Colonoscopy Conjoint Committee (<u>RCCC</u>)
- The RCCC comprises representatives from GESA, RACP and RACS and is the only organisation currently providing recertification of medical and surgical colonoscopists in Australia.
- The program provides for triennial recertification and incorporates:
 - o a formal recertification program using evidence from your online logbook
 - o training and education opportunities for practicing colonoscopists

Steps in the recertification process are:

- Hold CCRTGE certification for Colonoscopy
- Register online with the <u>Recertification in Colonoscopy Program</u>
- Log consecutive adult colonoscopies and upload or keep supporting records of any necessary imagery and pathology reports
- When the criteria are satisfied, submit the online logbook and pay submission fee
- Undertake recertification every 3 years using your established RCCC logbook









Practitioners seeking recertification as an adult colonoscopist are required to:

- Hold CCRTGE certification for Colonoscopy
- Completed at least 150 consecutive colonoscopies over 3 years, which can be recorded in batches of 50. It is a requirement that at least 50 are performed in the 12 months prior to the application.
- Ensure at least 95% of the 150 procedures are to the caecum or terminal ileum of intact colons
- Ensure the adenoma detection rate is at least 25% in eligible* patients
- Ensure the sessile serrated adenoma/polyp detection rate is at least 4% in eligible* patients
- Complete a short, online 'cognitive review' which provides links to education tools for further education and information.

The minimum criteria to be met for recertification are available here.

* Eligible patients are defined as 50 years of age or older, have intact colons and who had no indication of IBD prior to their colonoscopy.

Applicants will be notified once an application has been assessed as satisfactorily meeting the criteria for recertification by the RCCC panel. Applicants that do not initially meet the criteria will be provided with feedback from the panel. This may include information on relevant education and training opportunities and/or requirements to submit further data and supporting records.

Nurse endoscopists

Nurse endoscopists are certified and recertified through their jurisdiction. The same standards of training as medical and surgical colonoscopists in the procedure and the same quality assurance mechanisms are expected to apply.
